

Employment and Productivity and the Minister of Public Building and Works consider it desirable that this proposal should be the subject of an independent investigation by the National Board for Prices and Incomes.

Accordingly, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Public Building and Works, acting jointly in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, hereby refer to the National Board for Prices and Incomes for their examination and report the proposal made by the Cement Makers' Federation to increase by 12s. 0d. per ton the prices currently charged for Portland Cement by its members under their approved common price arrangement, being the prices specified in the Federation's current price schedules, and charged on sales to users by members of the said Federation, namely, Associated Portland Cement Manufacturers Ltd., Tunnel Cement Ltd., The Rugby Portland Cement Co. Ltd., Aberthaw and Bristol Channel Portland Cement Co. Ltd., Ribblesdale Cement Ltd., Ketton Portland Cement Co. Ltd., and Imperial Chemical Industries Ltd.

Y SWYDDFA GYMREIG HIGHWAYS ACT 1959

The London—Fishguard Trunk Road (Ffynnon Bridge, near Commercial, Side Roads) Order 1969
The Secretary of State hereby gives notice that he has made an Order under section 9 of the above Act authorising the Secretary of State:

- (a) to stop up highways
- (b) to construct a new highway to connect the superseded length of the Trunk Road with the route of the new trunk road, all at Ffynnon Bridge near Commercial in the County of Pembrokeshire and provide for the transfer of the said highway to the County Council of Pembrokeshire as from the date on which the Secretary of State notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the Order and of the relevant plan have been deposited at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, where they are open to inspection free of charge at all reasonable hours. Copies have also been deposited at the offices of Pembrokeshire County Council, County Offices, Haverfordwest, where they are similarly open to inspection.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1959, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied within relation to the Order, may, within six weeks from 15th August 1969, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
