The Minister of Transport has made an Order under sections I and 84D of the Road Traffic Regulation Act 1967 the effect of which is to amend the Trunk Road (Bury New Road, Prestwich) (Prohibition of Waiting) Order 1965 so that, in addition to the waiting restrictions already in force, loading and unloading is prohibited between the hours of 8 a.m. and 9.30 a.m. any day other than a Sunday; or between the hours of 4.30 p.m. and 6.30 p.m. on any other

day other than a Saturday or a Sunday in the length of road specified in the Schedule to this notice.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle except as specified above or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

Any person who desires to question the validity of, or of any provision contained in, the order, on the ground that it is not within the powers with respect to the order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 15th August 1969 apply to the High Court for the suspension or quashing of the order or of any provision contained therein. therein.

That length of the Manchester—Burnley Trunk Road (A.56), known as Bury New Road in the borough of Prestwich, which extends from its junction with St. Mary's Road to a point 100 yards north of its junction with Kingswood Road.

The Trunk Road (Prohibition of Waiting) (Clearways)

The Minister of Transport proposes to make an Order under sections 1 (1), (2), (3) and (6) and 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which will be:

- to prohibit waiting on any of those main carriageways forming part of the London—Great Yarmouth Trunk Road (A.12) which are specified in the Schedule hereto; and
- to prohibit waiting by any vehicle for the pur-pose of trading, unless the goods are immediately delivered at or taken into premises adjacent to the vehicle, on any verge or lay-by adjacent to the said main carriageway.

The prohibition imposed by the Order will not

- (a) to a vehicle waiting upon the direction or with
- the permission of a police constable in uniform;
 (b) so as to prevent a vehicle from being used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or of any of the services therein;

of the services therein;
(c) to a vehicle being used for fire brigade, ambulance or police purposes;
(d) to a vehicle being used for the purpose of delivery or collecting postall packets;
(e) to a vehicle being used by or on behalf of a local authority for the purpose of collecting household refuse or clearing cesspools;
(f) to a vehicle waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has

vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait elsewhere; and (g) to a vehicle waiting in any case where the

person in control of it:

(i) is required by law to stop;
(ii) is obliged to stop to avoid an accident; or
(iii) is prevented from proceeding by circumstances outside his control and cannot remove the vehicle from the main carriageway.
