TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

Birkenhead

The Minister of Transport hereby gives notice that he proposes to make an Order under section 91 of the Town and Country Planning Act 1968 to authorise the stopping up of lengths of St. Paul's Road, a footpath off Mersey Road, Bedford Road, Rock Lane East, Delta Road, St. Peter's Road and The Dell and parts of Mersey Road and Mersey Lane South,

Birkenhead, in the interests of the safety of users of and to facilitate the movement of traffic on the Rock Ferry By-pass, Birkenhead (which is a highway to be constructed in accordance with planning permission granted under Part III of the Town and Country Planning Act 1962).

The proposed Order will require the provision of new highways maintainable at the public expense, for which the highway authority is to be the Birkenhead C.B.C.

Birkenhead
