

THE PETROLEUM (PRODUCTION) REGULATIONS 1966

The Minister of Power hereby gives notice that in pursuance of the powers conferred upon him by section 2(1) of the Petroleum (Production) Act 1934 and in accordance with the provisions of the Petroleum (Production) Regulations 1966, he has granted to the persons named in the Schedule below production licences in respect of the landward areas respectively shown in the said Schedule against the names of those persons.

Areas are bounded by lines drawn between grid points ascertainable with respect to the National Grid. Except where otherwise indicated in the Schedule, such boundaries are straight lines between the grid points named. Maps illustrating the boundaries are available for inspection at the Ministry's office at Thames House South, Millbank, London, S.W.1.

Public Health Act, 1936
Public Health (Ships) Regulations 1966

The Secretary of State for the Social Services hereby declares, in pursuance of regulation 12 of the Public Health (Ships) Regulations 1966, that with effect from the 1st September 1969 until he shall otherwise declare, (a) the district of the London Port Health Authority shall be a district for the receipt and transmission of radio messages to and from ships before arrival in the above district, for the purposes of those regulations, and (b) regulation 14 (2) of those regulations (which requires that radio messages sent in code shall comply in certain respects with the 1931 International Code of Signals) shall apply to such district as if for such code there were substituted the 1969 International Code of Signals.

TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

Ashford, Kent

The Minister of Transport hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 to authorise the stopping up of a length of Woolreeds Road off Beaver Lane, Ashford, Kent to enable residential development to be carried out by Ashford U.D.C. under Part III of the said Act.

The proposed Order will require the provision of a new footpath maintainable at the public expense, for which the highway authority is to be the Ashford U.D.C.

During 28 days from the 29th August 1969 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the U.D.C. Offices, Church Road, Ashford and may be obtained free of charge from the Ministry of Transport (quoting HLL 70/19/0248) at the address stated below.
