PRICES AND INCOMES ACT, 1966

REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

Costs and Revenue of National Newspapers

In July 1967 the National Board for Prices and Incomes was requested by the Government to examine and report on the costs and revenue of national daily newspapers with a circulation of over 200,000 and in October 1967 the Board submitted its Report (which was published as Cmnd. 3435). The devalua-tion of sterling had substantial effects on the costs of newspapers and many of these increment their prices of newspapers and many of these increased their prices in 1968.

Under the arrangements for voluntary early warn-ing of price increases, several publishers of national newspapers have now notified the Board of Trade that they propose to make price increases, some immediately and others in 1970. Having regard to the facts of the cases for the immediate increases, the Government are not asking that they should be withheld. But, in view of the special role of the newspaper industry and its continuing economic problems, the Government consider that the increases in prices proposed to be made in 1970 require further independent examination of the costs and revenue of the main national newspapers.

Accordingly, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act, 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Board of Trade hereby refer to the National Board for Prices and Incomes for examination the question of the costs and revenue of national newspapers with a circulation over 200,000.

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit waiting on any day other than a Sunday:

- (a) on any of the sides of road or in the length of road specified in Schedule 1 to this notice; and
- (b) between the hours of 8 a.m. and 6 p.m. on any of the sides of road specified in Schedule 2 to this notice for a longer period than 30 minutes in any hour.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or un-loaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; to enable the vehicle to be used in the service of a to chable the venicle to be used in the service of a local authority in pursuance of statutory powers or duties, or to enable the vehicle to take in petrol, oil, water or air from any garage situated on or ad-jacent to any of the sides of road or the length of road so referred to.

The restrictions referred to in (b) above do not apply to:

(a) an invalid carriage;

 (b) a vehicle issued to a disabled person by the Government in lieu of an invalid carriage;
- (c) a vehicle left by the driver thereof, who is a person who on account of his severe physical disability has been given a notice in writing by Breconshire County Council that he is exempt from the restrictions, if the notice is displayed on the vehicle in a conspicuous position; and
- (d) a vehicle left by the driver thereof, being a vehicle which bears at the front and the rear in conspicuous positions yellow badges issued by
