#### COMMISSION ON INDUSTRIAL RELATIONS

*Reference of a Matter to the Commission on Industrial Relations concerning relations between the Management and Employees of Armstrong Patents Company Ltd.*

The First Secretary of State and Secretary of State for Employment and Productivity refers to the Commission on Industrial Relations for examination the functioning and development of institutions and procedures for the conduct of industrial relations between Armstrong Patents Co. Ltd., Bucklersbury House, London E.C.4, on the one hand and the company's employees at York and their representatives on the other; and for consideration of measures for the promotion of any improvements in such institutions, procedures and relations that appear necessary, taking account of any change in institutions, procedures and relations which may occur in the engineering industry while the reference is under examination; and to report.
