### ROAD TRAFFIC REGULATION ACT 1967

*Extension of 30 m.p.h. Speed Limit, Imposition of 40 m.p.h. Speed Limit and Reduction of 50 m.p.h. Speed Limit.*

Notice is hereby given that the Minister of Transport intends to make Orders under sections 72 (3), 73 (1), 74 (1) and 84 D (1) of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968, the effect of which will be that the lengths of Trunk Road specified in Schedules 1 and 2 to this notice shall become subject to speed limits of 30 m.p.h. and 40 m.p.h. respectively. The length of Trunk Road specified in Schedule 2 is at present subject to a speed limit of 50 m.p.h.

Any objection to the making of the Order should be sent to the Divisional Road Engineer, Ministry of Transport, "Edgeborough", Epsom Road, Guildford, Surrey, not later than 7th March 1970, quoting the reference number DSE 300/28/2/TR 6/02.
