TEESSIDE COUNTY BOROUGH COUNCIL

The County Borough of Teesside (Various Streets at Middlesbrough) (Experimental Prohibition of Driving) (No. 1) Order, 1969.

Notice is hereby given that on the 16th February 1970 the Council of the County Borough of Teesside made an Order under section 9 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit any person from causing any vehicle to enter or leave any of the roads specified in column 1 of the Schedule to this notice at the junction with the road specified in relation to that road in column 2 of the aforementioned reasons.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from 16th February 1970, apply to the High Court for this purpose.

TEESSIDE COUNTY BOROUGH COUNCIL

The County Borough of Teesside (Newport Area, Middlesbrough) (Experimental Prohibition and/or Restriction of Waiting and Loading or Unloading) (Variation No. 1) Order, 1970.

WALLASEY COUNTY BOROUGH COUNCIL

Notice is hereby given that the Wallasey County Borough Council propose to make Orders under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be as follows:

The County Borough of Wallasey (Twickenham Drive) (Prohibition of Waiting) Order, 1970.

To prohibit the waiting of vehicles, subject to the usual exemptions, at all times on the north side of Twickenham Drive from its junction with Livingstone Road for a distance of 140 yards in an easterly direction.
