The Queen's Most Excellent Majesty in Council Whereas the Church Commissioners have, in pursuance of the Church Building Acts 1818 to 1884 as they have effect in the Island of Jersey and of the

Church Commissioners Measure 1947, duly prepared and laid before Her Majesty in Council a Representation bearing the date the 22nd day of January 1970 in the words and figures following, that is to say:

"We, the Church Commissioners for England, acting under the provisions of the Church Building Acts 1818 to 1884 as they have effect in Jersey and under the Church Commissioners Measure 1947, have prepared and humbly lay before Your Majesty in Council the following Representation as to the assignment of a Compolidated Chapelry to

Majesty in Council the following Representation as to the assignment of a Consolidated Chapelry to the consecrated Church of Saint Matthew in the parish of Saint Lawrence in the Island of Jersey and in the diocese of Winchester:

"Whereas it appears to us to be expedient that certain contiguous portions of the parish of Saint Lawrence, Jersey, the parish of Saint Andrew, Jersey, and the parish of Saint Peter, Jersey, should be formed into a Consolidated Chapelry for all ecclesiastical purposes, and that the same should be assigned to the said Church known as Saint Matthew, Millbrook situate as aforesaid, and that the right of presentation thereto should be vested in and be exercisable by Your Majesty, Your Heirs and Successors; Successors
