pass through a narrow porthole. Siliko deliberately waited in the cabin to assist his cabin mate to escape. After his cabin mate escaped into the harbour Siliko managed to squeeze through a porthole on the second attempt and then swam to the wharf and

assisted with the firefighting. Siliko displayed great personal courage, initiative and disregard for his own safety in saving the life of his cabin mate.
