

The Regulations also prohibit the sale or letting on hire for use in a factory of certain abrasive wheels which are not marked with their maximum permissible speeds and of certain machines on which abrasive wheels are or are intended to be mounted to which the notice as to working speeds is not affixed as required by the Regulations.

Town and Country Planning Acts 1962 and 1968

The Secretary of State hereby gives notice that he proposes to make an Order under Section 153 of the Town and Country Planning Act 1962 to authorise the stopping up of a length of unclassified road at Llanilid, near Bridgend in the county of Glamorgan, extending from a point on the Pentre Meyrick to Brynna Road approximately 240 yards south of its junction with New Road (A.473) in a north-easterly direction for a distance of 490 yards to its junction with New Road (A.473) at a point near Rhyd-Y-Gofer Farm, to enable development consisting of opencast coal mining to be carried out in accordance with planning permission granted to the National Coal Board under Part III of the said Act.

During 28 days from the date of publication of this notice copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Cowbridge Rural District Council Offices, 79 Eastgate Street, Cowbridge, Glamorgan and at the address of the Clerk to the Llanilid Parish Meeting, The Old Rectory, Llanilid, Pencoed, nr. Bridgend, Glamorgan and may be obtained free of charge on application to the Welsh Office (quoting RD 37/1/382/01) at the address stated below.

The Trunk Road (Pont Abraham and Drefach) (Temporary Prohibition of Traffic) Order 1970

Notice is hereby given that to enable works to be carried out the Secretary of State intends to make an Order under section 12 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that:

1. No person shall cause any vehicle to proceed in that length of the London—Fishguard Trunk Road (A.48) at Drefach in the County of Carmarthen, which extends from a point 560 yards each of its junction with the Tumble—Llansawel Road (B.4310) to a point 610 yards east of that junction.
2. No person shall cause any vehicle to proceed in that length of the London—Fishguard Trunk Road (A.48), at Pont Abraham in the County of Carmarthen, which extends from a point 151 yards south of its junction with Pont Abraham Bridge in a southerly direction for a distance of 50 yards.

The Order will come into operation on the 24th April 1970 and will remain in force until the works have been completed.

During the period of works it will be necessary for traffic affected by the Drefach closure to use the following alternative routes:

1. For Westbound Traffic

Via A.476 at Crosshands to B.4310 to rejoin A.48 at Drefach.

2. For Eastbound Traffic

Via the classified road at Porth-y-rhyd, through Foel-gastell to rejoin the A.48 west of Cwm-y-glo. Traffic will not be affected by the Pont Abraham closure as a diversion route has been constructed alongside the A.48.
