#### SCHEDULE

##### *Conservation Area—City of Ely*

The designated area comprises all the land included within a line running from the western and northern boundaries of St. Johns Barn on the south side of St. Johns Road, and thence eastwards for 40 yards; thence northwards to the rear boundaries of Clare Cottages and other properties in St. Johns Road and so to West End; thence eastwards to the junction of Chiefs Lane and northwards for 30 yards; thence south-eastwards along the rear of properties in West End; thence from a point at the rear of 88 West End generally north-eastwards to West Fen Road 30 yards west of Waterloo House; thence south-eastwards to the northern boundary of 2A West Fen Road; thence generally in a north-easterly direction at the rear of properties in St. Mary's Street to a point at the rear of 10 St. Mary's Street; thence northwards to and across Chapel Street to the west side of Huntingdon Manse and including the Congregational Church; thence eastwards at the rear of properties in Chapel Street for 50 yards; thence northwards to Egremont Street and 80 yards westwards along Nutholt Lane and turning opposite the new Fire and Ambulance Station to run southwards for 50 yards to the rear of properties in Market Street; thence for 100 yards generally eastwards and along the northern boundary of 15 Newnham Street and across Newnham Street opposite No. 15 to include the properties in Market Street at a depth of 70 yards to include the G.P.O. and Messrs. crossing Lisle Lane and Willow Walk to Waterside; thence eastwards for 100 yards on the northern boundary of properties in Waterside; thence southwards to and across the River Ouse; thence along the boundary of Babylon eastwards for 150 yards; thence south-westwards continuing along the boundary of Babylon to the River Ouse; thence northwards alongside the river to the Ferry landing stage and crossing the river south-westwards for 110 yards to the rear of properties in Station Road; thence north-westwards to Annesdale; thence south-westwards across Station Road and thence north-westwards to Potters Lane; thence north-eastwards for 100 yards into Broad Street; thence along the western and southern boundaries of St. Peter's Church; thence for 80 yards south-eastwards to the rear of properties in Annesdale; thence generally north-eastwards to Back Lane; thence north-eastwards to the rear of properties on the west side of Broad Street; thence generally south-westwards skirting the Park and at the rear of properties in Broad Street and Back Hill to the front boundary of the former Needhams School in Back Hill; thence to Barton Square and to the rear of the properties in the Square to Silver Street; thence northwards to the rear of properties in Silver Street and re-crossing Silver Street at the Prince Albert Public House and along the frontage of Silver Street to the rear boundary of the White Horse Public House in St. Mary's Street and thence northwards to St. Mary's Street; thence generally westwards across Cambridge Road and to the rear of properties in West End and along the rear boundary of St. Johns Farm to St. Johns Barn.
