6. no person shall cause any vehicle proceeding in a north-westerly direction in the south-western carriageway of the London—Fishguard Trunk Road (A.48) (hereinafter referred to as "the trunk road"), in the Borough of Port Talbot in the County of Glamorgan, to make a turn through the opening in the central reservation situated opposite the junction of the trunk road with the access road to Baglan Road, Baglan, so as to enter the north-eastern carriageway of the trunk road.
