

the First Secretary of State and Secretary of State for Employment and Productivity and the Secretary of State for Social Services hereby refer to the National Board for Prices and Incomes, for their examination and report, the recommendations contained in Cmnd. 4352 relating to the basic remuneration of hospital doctors and dentists, other than that of the training grades, and the net remuneration of general medical and general dental practitioners. The Review Body recommended for these groups increases of 30 per cent. from 1st April 1970, to last until 1st April 1972; the Government have decided to grant immediate payments on account from 1st April 1970 of 15 per cent. and the Board are asked to report on how much of the balance should be paid from that date.

Town and Country Planning Acts 1962 and 1968

The Secretary of State hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act, 1962, to authorise the stopping up of the following lengths of highway in the Urban District of Rhyl:

1. *Walford Avenue*:—From a point 177 yards from its junction with Cefndy Road to its north-eastern end, a distance of 146 yards;
2. *Aled Avenue*:—From a point 65 yards from its junction with Cefndy Road to its junction with Walford Avenue, a distance of 48 yards; and
3. *Part of Footpath leading from Walford Avenue to Vale Road*:—From its junction with the north-eastern end of Walford Avenue to a point 94 yards south-west of its junction with Vale Road, a distance of 43 yards;

to enable residential development to be carried out in accordance with planning permission granted to Rhyl Urban District Council under Part III of the said Act.

The proposed Order will require the provision of new footpaths maintainable at the public expense for which the highway authority is to be the Rhyl Urban District Council.

During 28 days from the date of publication of this notice copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Rhyl Urban District Council Offices, Clwyd Street, Rhyl, Flintshire, and may be obtained free of charge from the Welsh Office (quoting the reference number RD 37/1/354/01) at the address stated below.
