Notice is hereby given that the Secretary of State intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall cause any vehicle proceeding in a westerly direction in that length of the London—Fishguard Trunk Road (A.40) known as Coracle Way in the Borough of Carmarthen, to make a right-hand turn into Little Bridge Street.
