## MINISTRY OF TRANSPORT

### ROAD TRAFFIC REGULATION ACT 1967

*The Trunk Road (Peterborough) (Restriction of Waiting, Loading and Unloading) Order 1970*

1. The Minister of Transport has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be:

- (a) to prohibit the waiting of vehicles, between the hours of 8 a.m. and 6.30 p.m. on the parts of roads specified in Schedule 1 to this notice;
- (b) to limit between the hours of 8 a.m. and 6.30 p.m. the length of time during which vehicles may wait to one hour in any 2 hours in the parts of road specified in Schedule 2 to this notice;
- (c) to replace the existing limited waiting by a prohibition of waiting between the hours of 8 a.m. and 8 p.m. on the part of road specified in Schedule 3 to this notice.
- (d) to extend the existing prohibition of waiting 8 a.m. to 8 p.m. on that part of road specified in Schedule 4 to this notice.
