

- (x) Prohibiting waiting between 8 a.m. and 6.30 p.m. (Mondays to Saturdays inclusive) on the east side of Priory Street from a point 34 yards north of Midland Road to a point 48 yards south of Alexandra Place.
- (y) Limiting waiting to half an hour in any one hour between 8 a.m. and 6.30 p.m. (Mondays to Saturdays inclusive) on the east side of Roise Street from a point 25 yards south of Bromham Road to a point 60 yards south of Bromham Road.
- (z) Prohibiting waiting between 8 a.m. and 10 p.m. (on any day) on the north side of St. Paul's Square (both sides) along its whole length.
- (aa) Prohibiting waiting between 8 a.m. and 10 p.m. (on any day) on the south side of St. Paul's Square from High Street to a point 100 yards west of High Street.

The Orders "(A) to (F)" make it unlawful to leave your car during the following hours on parts of:
