

This Order prohibits waiting by vehicles at any time on that part of Crythan Road and Old Road, Neath, from the Glamorgan Hotel to School Road (west side) and comes into operation on 31st day of August 1970.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the

Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may, within six weeks from the 28th day of July 1970, apply to the High Court for this purpose.

Proposed Traffic Regulation Orders

Notice is hereby given that the Nottinghamshire County Council propose to make Orders under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, imposing restrictions on the waiting of vehicles on the lengths of road shown in the first column of the Schedule hereto. The restrictions will apply for the periods shown in the second column of the Schedule and a copy of each proposed Order and a plan showing the lengths of road affected may be inspected during normal office hours at the address shown opposite such Order in the third column of the Schedule or at my office.

OXFORD CITY COUNCIL

The City of Oxford (Catte Street) (Prohibition of Entry) Order 1970

Notice is hereby given that on the 3rd August 1970, the Oxford City Council made the above-named Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

This Order, which makes it unlawful for vehicular traffic (except as provided below) to enter Catte Street from Holywell Street, Parks Road or Broad Street, will come into operation on the 30th August 1970.

Pedal bicycles and pedal tricycles will be exempt from the restrictions described above.
