PRESENT

The QUEEN's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 3 of the Naval and Marine Pay and Pensions Act 1865 (28 and 29 Vict. c. 73) and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

Citation

1. This Order may be cited as the Naval and Marine Pay and Pensions (Pay and Allowances) Order 1970.

General

2. The revised rates of pay and allowances set out in the Schedules to this Order shall have effect from 1st April 1970 except as may be specified otherwise in this Order and shall be payable subject to the regulations made by the Defence Council or the Admiralty Board on their behalf, in respect of Officers, Ratings and Other Ranks of the Royal Navy and Royal Marines and of members of the Naval and Marine Reserves while serving or training in Her Majesty's Ships or Establishments; the said rates and allowances shall not apply to Officers appointed for time only or otherwise holding Naval rank for purposes of status only or to personnel recruited abroad for local service. In Schedules 1 to 4 the rates of pay and allowances shall be as set out in the columns headed Standard Rates but for the period from 1st April 1970 to 31st March 1971 inclusive the rates set out in the columns headed Interim Rates shall be payable. The rates in the Schedules shall be read as daily rates, unless otherwise specified.

3. For the period 1st April 1970 to 31st March 1971 only, the rates of pay of Officers, Ratings and Other Ranks who were not in receipt of Marriage Allowance or State Supplement on 31st March 1970 shall be calculated in accordance with Schedule 3 by deducting, as appropriate, the amounts shown in that Schedule from the daily rates shown in the appropriate columns of Schedules 1 and 2.

4. Increments of pay for Officers of the Royal Naval Reserve and the Royal Marine Reserve shall depend on mobilised service at naval rates of pay in the confirmed or paid acting rank, or as may be provided by the Defence Council or the Admiralty Board on their behalf.

5. A Supplement to Pay shall be payable to any Officer, Rating or Other Rank, Royal Marines who in consequence of the revision of pay and allowances would otherwise receive a lower net rate of pay after 1st April 1970 than he was receiving prior to that date.

6. Allowances to be abolished or revised shall be as set out in Schedule 4. Education grants may be awarded in accordance with Schedule 5.

7. A Family Maintenance Grant may be made to the wives of Ratings and Other Ranks, Royal Marines during periods when their husbands are in detention, subject to the conditions set out in Schedule 6.

8. An allowance may be paid to the dependants of any Officer, Rating or Other Rank, Royal Marines who is reported to be missing, subject to the conditions set out in Schedule 7.

9. With effect from 1st April 1970 all Officers, Ratings and Other Ranks of the Royal Navy and Royal Marines and members of the Naval and Marine Reserves while serving or training in Her Majesty's Ships or Establishments shall be liable to pay charges for food and accommodation. Payment shall be effected by deductions from pay at such rates and subject to such conditions as are laid down from time to time by the Defence Council or by the Admiralty Board on their behalf.

- 10.—(1) The rates of pay and allowances in the Schedules to this Order shall from 1st April 1970 supersede the corresponding rates of pay and allowances set out in Orders previously made under section 3 of the Naval and Marine Pay and Pensions Act 1865; and where any allowance is abolished by this Order, the provisions formerly pertaining to that allowance in any Order shall from that date be of no effect, except insofar as the allowance is payable to any person in respect of a period of service covered by such Order.

- (2) Without prejudice to the foregoing sub-paragraph, the Naval and Marine Pay and Pensions (Pay and Allowances) Order 1969 shall be amended in paragraph 1 (Seaman Branch) of Schedule 2 as follows: the first entry under the column headed "Scale A" shall in place of "29s. 3d." read, and be deemed always to have read, "29s. 6d."
