

*The Trunk Road (Barn Park Hill, Launceston Road, Bodmin) (Weight Restriction) Order 1970**Bodmin*

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be that no person shall cause any vehicle (other than a Public Service Vehicle) the unladen weight of which exceeds 4 tons to proceed in a south-westerly direction in that length of the London—Penzance Trunk Road (A.30), known as Barn Park Hill, Launceston Road in the Borough of Bodmin in the County of Cornwall, which extends from its junction with Cooksland Lane to its junction with Priory Road.

A copy of the Order, together with a plan illustrating the proposal, may be inspected during all reasonable hours at the offices of the Bodmin Borough Council, Municipal Offices, Priory House, Bodmin.

*The Trunk Road (East Lancashire Road, Tyldesley) (Prohibition of Right-hand Turn) Order 1970**Tyldesley*

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be that no person shall cause any vehicle proceeding in an easterly direction in that length of the Liverpool—Leeds—Hull Trunk Road (A.580), known as East Lancashire Road in the Urban District of Tyldesley to make a right-hand turn into Mosley Common Road (A.577).
