Kingsland Road. West side from a point 321 feet south of its junction with Yorick Road southwards for a distance of 100 feet; and from a point 481 feet south of its junction with Yorick Road southwards for a distance of 90 feet.

Exceptions will permit waiting for the purposes of:

(a) picking up and setting down passengers, (b) loading or unloading goods,

and, where necessary, in connection with:

(c) the maintenance of the roads,

(d) the supply of gas, electricity and water, and

(e) the maintenance of Post Office Services.

The effect of the new Order will be to revoke the County Council of Essex (Various Streets, West Mersea) (Prohibition of Waiting) Order 1969, but the provisions contained in that Order will remain in force unchanged by virtue of the new Order.
