The County Council of Lincoln, Parts of Kesteven (Borough of Stamford) (Various Roads) (Prohibition and Restriction of Waiting) Order 1970

Notice is hereby given that the County Council of Lincoln, Parts of Kesteven, propose to amend their proposed Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, so far as relates to the restrictions on the south side of St. Peter's Street and the west side of St. Peter's Hill, Stamford, as follows:

St. Peter's Hill (West side) (from St. Peter's Street to Austin Street).	Waiting limited to 2 hours—9 a.m. to 6 p.m.	<i>No Waiting at any time</i> —between points 75 feet and 90 feet south of its junction with St. Peter's Street. <i>Waiting limited to 2 hours—9 a.m. to 6 p.m.</i> —from St. Peter's Street southwards for 90 feet and between points 90 feet and 143 feet south of its junction with St. Peter's Street.

LINCOLN COUNTY COUNCIL—PARTS OF KESTEVEN

The County Council of Lincoln—Parts of Kesteven (Easton Lane, Stoke Rochford) (Weight Restriction) Order, 1970.

Notice is hereby given that the County Council of Lincoln, Parts of Kesteven, propose to make an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be to prohibit the driving of any vehicle, the weight of which, whether laden or unladen, exceeds 5 tons on Easton Lane, Stoke Rochford, from its junction with the Great North Road (Trunk Road A.1) to its junction with the High Dyke (B.6403). There will be the usual exemptions in respect of the conveyance of persons, goods, etc., to or from any premises or land adjacent to the road.

LLANELLI BOROUGH COUNCIL**ROAD TRAFFIC REGULATION ACT 1967**

The Llanelli Corporation Traffic Regulation (General No. 2) Order 1970

Notice is hereby given that the Llanelli Borough Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

When this Order comes into effect you will not be allowed to:

- leave your vehicle at any time in any of the lengths of road mentioned in the First Schedule hereto.
- leave your vehicle for more than one hour or return within the following two hours between 8 a.m. and 6 p.m. from Monday to Saturday in any of the lengths of road mentioned in the Second Schedule hereto.

Exceptions will permit waiting for the purposes of:

- picking up and setting down passengers,
- loading or unloading goods and, where necessary, in connection with:
- the maintenance of the road, and
- the supply of gas, electricity and water.

Full details of these proposals are in the draft Order which, together with a map showing the restricted areas and a statement of the Council's reasons for proposing to make this Order may be examined at the Town Clerk's Office, Town Hall, Llanelli, during usual office hours.
