## WAGES COUNCIL

### WAGES COUNCILS ACT 1959

#### *Industrial and Staff Canteen Undertakings Wages Council*

The Industrial and Staff Canteen Undertakings Wages Council hereby gives notice of its intention to submit to the Secretary of State for Employment and Productivity proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Industrial and Staff Canteen) Order 1969 (Order I.S.C. (45)); and (2) the revocation of Order I.S.C. (45).

Particulars of the proposals are contained in the Wages Council's Notice I.S.C. (46) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 21 days from 18th August 1970. Any such representation should bear the writer's address and signature and be sent to the Secretary, Industrial and Staff Canteen Undertakings Wages Council, 12 St. James's Square, London S.W.1. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notice of Proposals I.S.C. (46).
