CIVIC AMENITIES ACT, 1967

Rural District of Wantage—Conservation Areas

Notice is hereby given that the County Council in pursuance of their powers under section 1 of the Civic Amenities Act, 1967, have designated certain areas situate within the Rural District of Wantage as Conservation Areas. A brief description of the areas is set out below:

1. *Aldworth*. The major part of the village including Parsonage Green and Hungerford Green.
2. *Ardington*. The major part of the village extending towards East Lockinge.
3. *East Lockinge*. Narrow area extending from the Rectory to Lockinge Farm.

4. *Blewbury*. That part of the village bounded by Westbrook Street, Berry Lane, South Street from Bessels Lea to Dibleys, the rear boundaries of property fronting South Street from Dibleys to the "Barley Mow" Public House and the rear of the properties fronting the south side of London Road.
5. *Childrey*. The major part of the village, excluding parts of Chapel Way and West Street.
6. *Denchworth*. The major part of the village.
7. *East Ilsley*. The major part of the village.
8. *Farnborough*. The whole of the village.
9. *Harwell*. The entire length of High Street, Church Lane and Chilbrook, with parts of Burr Street, King Street, Talbots Lane, Jennings Lane, Wellshead Lane and Broadway.
10. *Letcombe Regis and Letcombe Bassett*. The major part of Letcombe Regis and the whole of Letcombe Bassett including the Letcombe Brook and watercress beds between the villages.
11. *Sparsholt*. The major part of the village.
12. *West Hanney*. That part of the village in the vicinity of St. James' Church, Hanney House and the Village Cross.
13. *West Hendred*. The southern end of the village.
14. *West Ilsley*. The whole of the village.

The relevant documents and plans may be inspected during normal office hours either at the offices of the Wantage Rural District Council, Belmont, Wantage, or at the County Planning Department, Surley House, Friar Street, Reading.
