(a) The Borough of Stretford (Bennett Street, Cyprus Street and Mitford Street) (Prohibition of Entry into Kingsway) Order, 1970.

To prohibit entry into Kingsway from Bennett Street, Cyprus Street and Mitford Street.

(b) The Borough of Stretford (Various Streets) (Prohibition of Waiting) Order, 1968 (Trafford Park Streets Amendment) Order, 1970.

To prohibit waiting from Monday to Friday and between 7 a.m. and 6 p.m. as follows:

Second, Ninth and Tenth Streets. The north sides for 50 feet in an easterly direction from Third Avenue.

Ninth and Tenth Streets. The south sides for 50 feet in a westerly direction from Third Avenue.

Eleventh Street. eventh Street. The south side from First Avenue to a point 50 feet west of Third Avenue. The north side for 75 feet in an easterly direc-

tion from Third Avenue.

(c) The Borough of Stretford (Chorlton Road and Moss Lane West) (Prohibition of Waiting) Order,

To impose the following prohibitions (a) on both sides of Chorlton Road from Brooks's Bar to Augustus Street and (b) on the north side of Moss Lane West from Brooks's Bar to a point opposite Sloane Street:

No Waiting-

Monday to Friday 8 a.m. to 6 p.m. Saturday 8 a.m. to 12.30 p.m.

No Loading and Unloading of Goods-Monday to Friday 8 a.m. to 9.30 a.m. Monday to Friday 4.30 p.m. to 6 p.m. Saturday 8 a.m. to 9.30 a.m.

Any person who desires to question the validity of any of the Orders or of any provision contained therein on the ground that it is not within the powers contained in section 1 of the Road Traffic Regulation Act, 1967, as amended, or on the ground that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order may within 6 weeks from the 19th August 1970, make application for the purpose to the High Court.
