The Urban District of Benfleet (Various Roads, South Benfleet) (Restriction of Waiting) (Amendment No. 2) Order 1970

Notice is hereby given that the Urban District Council of Benfleet on 17th August 1970, made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is to amend The Urban District of Benfleet (Various Roads, South Benfleet) (Restriction of Waiting) Order, 1968, as amended by The Urban District of Benfleet (Various Roads, South Benfleet) (Restriction of Waiting) (Amendment No. 1) Order 1969, prohibiting or restricting waiting in various roads in South Benfleet by:

(a) The deletion of the following restrictions:
