## NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT, 1968,  
SECTION 94*(Footpaths No. 1059 and 1060, Braithwaite,  
Cumberland) Diversion Order 1970*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 13th August 1970, is about to be submitted to the Minister of Housing and Local Government for confirmation or to be confirmed by the Lake District Planning Board as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public rights of way running from

- (a) the point on the track (Point C) north of Coledale Hotel along footpath No. 1059, across Old Mill Common to Point D west of the north-western corner of "Little Garth"; and
- (b) the point (Point B) on the footpath No. 1060 north of the northernmost corner of "Treetops" and east of Point C, north and east along the path to the point (Point A) east of "The Green" on the track leading to Whinlatter Road; to a line running from a point (Point F) to the immediate east of Point C on the track north of Coledale Hotel, east and northwards through a point on path No. 1060 immediately north of Point B, through Point D veering north to the track leading to Whinlatter Road.

A copy of the Order and map contained in it has been deposited at the Police Station, Braithwaite, Cumberland, and the offices of the Clerk of the Lake District Planning Board, County Hall, Kendal, Westmorland, and may be inspected free of charge at these offices between the hours of 9 a.m. and 5 p.m. on normal working days.

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the Lake District Planning Board, County Hall, Kendal, Westmorland, not later than 25th September 1970, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Lake District Planning Board may, instead of submitting the Order to the Minister of Housing and Local Government for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Minister for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Minister with the Order.

## LONDON BOROUGH OF BRENT

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

SECTION 94*The London Borough of Brent Central Road to  
Sudbury Crescent, Wembley, Public Path Diver-  
sion Order, 1970.*

Notice is hereby given that on 12th August 1970, the London Borough of Brent confirmed the above-named Order.

The effect of the Order is to divert part of the public right of way running from Central Road to Sudbury Crescent, Wembley, initially for a temporary period to a line to the west of the existing length of footpath and subsequently permanently to a line to the east of the existing footpath.

A copy of the confirmed Order and map contained in it has been deposited at and may be inspected free of charge at the office of the Director of Development (Planning), 4th Floor, Brent House, High Road, Wembley, Middlesex, between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays.

This Order becomes operative as from 28th August 1970, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act, 1968, or on the ground that any requirement of that Act or any regulation made

thereunder has not been complied with in relation to the confirmation of the Order, he may under section 178 of the Town and Country Planning Act, 1962 within six weeks from 28th August 1970 make application for the purpose to the High Court.

Path Stopping-Up Order, 1970*
