

FOLKESTONE BOROUGH COUNCIL

The Borough of Folkestone (Cherry Garden Lane) (Weight Restriction) Order, 1970

Notice is hereby given that on the 23rd September 1970, the Folkestone Borough Council made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall cause any vehicle the weight of which exceeds 3 tons unladen weight to proceed in that length of Cherry Garden Lane in the Borough of Folkestone which extends from its junction with Cherry Garden Avenue to its junction with Harcourt Road.

A copy of the Order, which comes into operation on 28th September 1970, may be inspected during normal office hours at the Town Clerk's Office, Civic Centre, Folkestone.

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by sections 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the 23rd September 1970, apply to the High Court for this purpose.

HARTLEPOOL COUNTY BOROUGH COUNCIL

The County Borough of Hartlepool (Stranton and Bell Terrace) (Prohibition of Driving) Order 1970

Notice is hereby given that on 17th September 1970 the Hartlepool County Borough Council made an Order under section 1 of the Road Traffic Regulation Act 1967 (as amended) the effect of which is to prohibit the driving of any vehicle in the lengths of road specified in the Schedule hereto.

Bell Terrace. From its junction with Stockton Street in a northerly direction for 14 feet.

HARTLEPOOL COUNTY BOROUGH COUNCIL

The Hartlepool (Shopping Centre) (Off-Street Parking Places) Order 1970

Notice is hereby given that the Council of the County Borough of Hartlepool in exercise of their powers under section 28 of the Road Traffic Regulation Act 1967 on 17th September 1970 made an Order, the effect of which is to regulate the parking of vehicles on the shopping centre (east) and the shopping centre (west) car parks and in the basement car park forming part of the Hartlepool shopping centre all of which car parks are within the area of the County Borough.

The Order incorporates the following main provisions:

1. In the case of the basement car park the classes of vehicles permitted to park are restricted to motor cars and approved invalid carriages only for a maximum period of four hours in any day. The basement car park will be open from Monday to Saturday from 9 a.m. to 8 p.m.

2. In the case of the other car parks the classes of vehicles permitted to park are restricted to motor cycles, motor cars, invalid carriages and vehicles constructed or adapted for the carriage of goods but not exceeding 30 cwt. of laden weight. These car parks (when completed) will be opened every

day and waiting restricted to a period of twelve hours.

3. No charges will be made to the drivers of vehicles waiting on any of the car parks to which this Order relates.

A copy of the Order together with a plan showing the car parks to which it relates may be inspected at my office during normal office hours.

HARTLEPOOL COUNTY BOROUGH COUNCIL

The County Borough of Hartlepool (Elwick Road, Park Road and Wooler Road) (Restriction of Waiting) Order, 1970.

Notice is hereby given that the Hartlepool County Borough Council on 17th September 1970 made an Order under section 1 of the Road Traffic Regulation Act, 1967, the effect of which is, with certain exceptions, to prohibit the waiting of vehicles between the hours of 7 a.m. and 7 p.m. on any day on either side of the lengths of roads specified in the Schedule.

A copy of the Order and of a map showing the roads to which it relates may be inspected at the Town Clerk's Department, Municipal Buildings, Hartlepool, during normal office hours.

THE SCHEDULE hereinbefore referred to

Park Road. From its junction with Elwick Road from a distance of 15 yards in an easterly direction.

Elwick Road. From a point 15 yards south of its junction with Park Road in a northerly direction to the junction with Wooler Road and then for a distance of 15 yards from the junction with Wooler Road in a westerly direction.

Wooler Road. From its junction with Elwick Road for 15 yards in a northerly direction.

Hartlepool (Fawcett Street/Ouston Street) (Off-Street Parking Spaces) Order, 1970

Notice is hereby given that the Council of the County Borough of Hartlepool in exercise of their powers under section 28 of the Road Traffic Regulation Act, 1967 (as amended) on 17th September 1970 made an Order, the effect of which is to regulate the parking of vehicles on the Fawcett Street/Ouston Street car park within the area of the County Borough. The Order would incorporate the following main provisions:

(1) The classes of vehicles permitted to park at these three car parks are restricted to motor cycles, motor cars, invalid carriages and vehicles constructed or adapted for the carriage of goods but not exceeding 30 cwt. of laden weight.

(2) The car parks will be open every day and waiting will be restricted to a maximum period of 12 hours.

(3) No charge will be made to individual drivers of vehicles waiting on these car parks.

A copy of the Order together with a plan showing the car park to which it relates may be inspected at my office during the normal office hours.
