ANNE R. ANNE, by the Grace of God, Queen of Great Britain, France and Ireland, Defender of the Faith, &c. To our trafty and well beloved Sir Alexander Erskin, Baronet, our trajty and meu-vecoven Sir Alexanucr Erskin, Baronet, Lyon King at Arms, and his Brethren, Héralds. Pursevants, and Messengers at Arms, our Sherists in that vare conjunctly and severally specially Constitute, Greeting. Forasmuch as by an AA passed in our Parliament of Great lain, bolden at Westminster in the Sixth Tear of our Restingly. An AA for rendring the Union of the Two Kingdom's more Intire and Compleat, it is amongst other things Enalted, That twice a Year, to wit, in the Months of A-pril or May, and in the Month of October, Circuit-Courts pril or May, and in the feveral Places mentioned in the Att of the third Selfions of the fecond Parliament of the late King Charles the Second, Instituted, An AC concerning the Regulation of the Judicatories; viz. at Dumfries and Jed-burgh, at Stirling, Glafgow, and Air, at Perth, Aberburgh, at Surling, Glaigow, and Air, at Perth. Aberdeen, and Invernels, in manner and form as in the faid AH is contained; and we being deferous that the faid Corcuits may be orderly and exactly kept and observed at the Places and Times aforesaid, by the Lord Justice-Clerk; and the other five Commissioners of Justiciary, by two and two to each of the faid three several and respective Districts, the Lord Justice-General being always supernumerary in any of these Circuit-Courts, and that Porteous Rolls be orderly and in due time taken up, conformable to the Law and Custom in such Cases, therefore we do hereby Appoint and Ordsin the next Circuit-Courts of Justiciary to be holden and kept by the said Judges and Commissioners in Scotland in the Month of May next ensuing, and to begin their Session on the sufficient of May next ensuing, and to begin their Session on the sufficient of Law in the said Month for the Shires, Bounds and Discourage and Law in the sufficient of Inverness the said suff law sufficient in May next to come, for the Shires of Inverness, Ross, Elgine, Caithness, Sutherland, Cromertie, Nairn, and Stewartries of Orkney and Zetland; At the Burgh of Air sor the Shire of Air and Jurisdictions within the same, and Shire of Wigtoun, the said sufficient in the Shire of Dumfrics for the Shire of Dumfrics for the Shire of Dumfrics for the Shire of Dumfrics and Nithsale, and Stewartries of Annandale and Kirkeudbright, the said sufficient Day in May, and to continue at the said respective Places, holding in due time taken up, conformable to the Law and Cuftom Courts for the space of six Days in the said Month of May next, if the Business before the said respective Places, wolding next, if the Business before the said respective Circuit-Courts do require so long time; At the Burgh of Aberdeen for the Shires of Aberdeen, Kincairden and Bamff; And at the Burgh of Glasgow for the Shires of Lanerk, Argyle, Dumbarton, Bute and Renfrew; At the Burgh of Jed-Dumbarton, Bute and Renfrew; At the Burgh of Jedburgh for the Shires of Roxburgh, Berwick, Selkirk, Peebles, and Bailliary of Lautherdale, upon the tenth Day of May next to come, if the same be a lawful Day, and failing thereof, the next lawful Day after, there to continue at each of the said Burghs for the respective Dustrists thereof, holding Courts for the space of six Days, if the Affairs of the respective Circuit-Courts to so require; At the Burth of Perth sor the Shires of Perth, Forsar, and Fyse; at the Burgh of Stirling for the Shires of Stirling, Clackmannan, and Kinrols, upon the twentieth Day of the said Month of May next to come, if the same be a lawful Day, and failing thereof, the next lawful Day thereafter, thence to continue at the said respective Burghs for the space of six Days, if the Affairs of the respective Circuit Courts do so require. And we require and command all manner of Foreguire. And we require and command all manner of Perfors, who by Law are bound to Compear before the Judges of the faid respective Circuit Courts, to give their

Attendance upon the several and respective Days, and at the Places asore mentioned, to do whatever in Law is sucumbent and ought to be done. And we require and command all and every such Person and Persons to give due Respects to our said Commissioners and Justices, and such special Assistance as to their Offices and Disties shall appertain. And in particular we require all our Sherists, that they cause sufficient and legal Men to Compear before our said Judges and Justices at the Diers and Places abovementioned, for being Assistant Winesses, as they shall be Cited to that Esseet. And we expect that the Sherists and Freeholders within our Shires of Inverness. Air and Dumfries, do meet and receive our said Justices at their Entry into the said Shires upon the Days they shall be Advertised, that the said Shires will Enter into the said Shires for holding the said Circuit-Courts; and they shall accompany our said Judges, until they shall be received by our next Shires and this Deputes into the next Shire. And our surfact Head Burghs of the several Shires, Stewarties, Regalities, and Bailliaries within Scolland, and there make open Proclamation of the Premiss, that none pretend Ignorance that Circuit-Courts are to be bolden at the several Places for the respective Districts and Precincis, and upon the particular Days above set down. Lisbon, March 9, N. S. His Excellency the Earl of Galloway having notified to the Secretary of State, that he was prepared to make his Publick Entry, that Ceremony was appointed to be performed on the 26th of the last Month. On the 23d, one of the first Officers of his Majesty's Houshold, attended by five of the King's Coaches, conducted his Excellency and Retinue to the Conde de St. Lorenzo's Quinta at Bethlem, where his Excellency was magnificently Treated three Days, and visited by the Portugueze Nobility, and all the Foreign Ministers residing in this Court. About Noon, on the 26th, his Excellency returned in the same manner to his own House, and about three of the Clock the Marquis das Minas, Councellor of State and Master of the Horie to the Queen, came to his Excellency's House in one of the King's Coaches of State, followed by the Queen's own Body Coach and four of the King's Coaches. The Marquis atquainted his Excellency that he was come by the King's Command to Conduct his Excellency to the Palace; upon which his Excellency was accompanied by the Marquis to the Door of the King's Coach, which his Excellency entred. That Coach was preceded by his Majesty's Family Coaches (filled with the Ambassador's Retinue) and the Queen's Body-Coach empty, with Curtains drawn, fix of his Excellency's Pages, dressed in very rich Liveries, walked on each fide of his Coach. The Marquis das Minas followed on Horseback behind the Coach, attended by two of his Excellency's Gentlemen of the Horse: After whom rid 21 British Officers very richly dressed, and mounted

mounted on Horles adorned with the most magnificent Furniture; after these came his Excellency's Equipage in the following Order. 24 Fuotmen two and two in fplendid Liveries led the way, after them a rich Litter, in the next Place a Coach of State-drawn by eight Horles; then tollowed a rich Painted Chariot drawn by fix; after that a Coach drawn by fix Mules; the Appearance was clos'd by fix led Horfes accourted in the most pompous manner. When his Excellency arrived at the Palace. he was received at the foot of the Stairs by Don Joseph Ignatio da Castro, Captain of the Guards, and Don Luis Dalmada, Master of the Ceremonies, who conducted him to the great Room for Audience of Ambassadors, where his Excellency had Audience of the King, and afterwards of the Oneen. After these Ceremonies were performed, his Excellency was attended to his own House in the same manner as he was conducted to the Palace.
