#### SCHEDULE 3

*Sides of lengths of the Haverfordwest—Milford Haven Trunk Road (A.4076) (hereinafter referred to as "the first trunk road"), in the Borough of Haverfordwest in the County of Pembroke.*

1. The north-west side of that length of the first trunk road, known as Dew Street, which extends from a point 13 yards south-west of its junction with Fountain Row to a point 140 yards south-west of its junction with Tower Hill.

2. The south-east side of that length of the first trunk road, known as Dew Street, which extends from a point 66 yards north-east of its junction with Shipman's Lane to a point 105 yards north-east of that junction.

3. The north side of that length of the first trunk road, known as High Street, which extends from a point 57 yards south-west of its junction with Castle Square to a point 10 yards south-west of that junction.

4. The north-west side of that length of the first trunk road, known as Barn Street, which extends:

(a) from a point 50 yards north-east of its junction with Portfield (B.4327) to a point 160 yards north-east of that junction; and

(b) from a point 385 yards north-east of its junction with Portfield (B.4327) to a point 100 yards south-west of its junction with City Road (A.487).

*Side of a length of the London—Fishguard Trunk Road (A.40) (hereinafter referred to as "the second trunk road"), in the Borough of Haverfordwest in the County of Pembroke.*

5. The east side of that length of the second trunk road, known as Prendergast, which extends from a point 50 yards south of its junction with Bull Lane to a point 30 yards south of its junction with Tan Bank.

#### EXPLANATORY NOTE

The proposed Order revokes and re-enacts with modifications all previous Orders which regulate traffic on lengths of the Haverfordwest—Milford Haven Trunk Road (A.4076) and the London—Fishguard Trunk Road (A.40) in the Borough of Haverfordwest.

The modifications are as follows:

(a) instead of waiting being limited between the hours of 8 a.m. and 6 p.m. to 1 hour in any 2 hours on specified sides of lengths of Dew Street, High Street, Picton Place, Barn Street, Perrot's Road and Old Bridge, it is proposed to prohibit waiting at all times except for the sides of the lengths of road specified in items 1, 2, 3 and 4 of Schedule 3 to this notice where limited waiting restrictions will still apply; and

(b) instead of waiting being prohibited between the hours of 8 a.m. and 6 p.m. on specified lengths and sides of Prendergast, Bridge End Square, Salutation Square and Cartlett, it is proposed to prohibit waiting at all times.
