#### Public Rights of Way

Notice is hereby given that, in accordance with the provisions of section 33 of the National Parks and Access to the Countryside Act 1949 and of Schedule 3 to the Countryside Act 1968, the Council of the London Borough of Redbridge, as the Surveyor the London Borough of Redorage, as the Surveying Authority, have reviewed the particulars contained in the Definitive Review Map and Statement which show public paths and roads used as public paths which existed on the relevant date of that map (1st January 1963), within the area of the London Borough and have determined the date of the review as 1st April 1970.

Having completed such review the Council have prepared a revised map and statement in draft form consisting of the Definitive Review Map and Statement subject to such modifications as appear to the Council to be requisite having regard to the review and to the requirements of Part III of Schedule 3 to the Countries Act 1969 to the Countryside Act 1968.

The alterations proposed in the special review arise by reason of

- (i) the exclusion from the review, with the approval of the Minister of Housing and Local Government, of four further areas of the borough (shown coloured pink on the above-mentioned Map) which are now fully developed (in consequence Rights-of-Way C.R.F. No. 9 and F.P. No. 18 have been deleted from both the Statement and the Map and F.Ps. Nos. 1 and 5 have been amended as to their lengths).
- (ii) the reclassification of those Rights of Way formerly designated "roads used as public paths" by the descriptions indicated, namely:

No. 4-" byway open to all traffic",

No. 5-" footpath", and

No. 14-" byway open to all traffic".

(Note: This description relates only to that part of the Right of Way as is situate between its junction with Carlton Drive and Dukes Drive and the eastern boundary of the railway bridge approach, the remainder of the Right of Way to Oaks Lane remains designated as a footpath.)

Notice is further given that any person is entitled to inspect the revised map and statement in draft form and to submit written representations or objections with respect to alterations effected by the draft revision or to anything omitted therefrom or to the reclassification of any road used as a public path.

Any such representations or objections should be sent in writing to the Secretary of State, Department of the Environment, Whitehall, London S.W.1, not later than the 10th day of April 1971, and should state the grounds on which they are made.
