(f) the taking in of petrol, oil, water or air from any garage situated on or adjacent to any of the sides of lengths of road;
(g) a vehicle to be used in the pursuance of

statutory powers.

A copy of the Order which becomes operative on 7th December 1970 together with a map showing the roads affected may be inspected at all reasonable hours at the Shire Hall (Room 213), Gloucester, and at the offices of the Tetbury Rural District Council, Long Street, Tetbury.

Any person wishing to question the validity of the Order or of any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, or on the ground that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, may, within six weeks of the date on which the Order is made, apply to the High Court for this purpose.
