Chard Rural District, Somerset (Footpath No. 4/16 at Avishayes, Chaffcombe) Public Path Diversion Order, 1970.

Notice is hereby given that the above-named Order made on the 27th November 1970, is about to be submitted to the Minister of Housing and Local Government for confirmation, or to be confirmed as an unopposed Order by the Somerset County Council.

The effect of the Order, if confirmed without modification will be to divert the part of public footpath No. 4/16 at Avishayes, Chaffcombe, which starts at a point near North Lodge approximately 30 yards south of Whitemoor Hill and runs in a southerly direction at the rear of Avishayes House for a distance of approximately 295 yards to the eastern end of the drive leading to Mals Mead Lane, to an alternative route starting near North Lodge, then running south-easterly and southerly around the eastern side of a field, then crossing a stile and

continuing in a south-westerly direction for approximately 220 yards to joint footpath No. 4/17 approximately 115 yards south-east of the drive referred to above.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the offices of the Clerk of the Chard Rural District Council, Snowdon House, Chard, or at the Post Office, Chaffcombe, during normal business hours.

Any representation or objection with respect to the Order may be sent in writing to the undersigned before the 5th January 1971, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the County Council may, instead of submitting the Order to the Minister of Housing and Local Government, themselves confirm the Order. If the Order is submitted to the Minister any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.—Dated 8th December 1970.
