STATUTE AMENDING SECTION 2 OF STATUTE XY CONCERNING FUNDS FOR PROVIDING EXHIBITIONS, BURSARIES AND PRIZES

We, the Warden and Fellows of Winchester College, being the Governing Body of Winchester College, do hereby, in exercise of the powers of the Public Schools Act, 1868, and of the Acts amending the same, and of all other powers enabling us in that behalf, resolve and enact as follows:

That the following proviso shall be added to Section 2 of Statute XV:

Provided also that the proceeds of the Cobden Fund shall be applied only towards an Exhibition to be tenable by a member of the University of Oxford or of the University of Cambridge.
