Road Traffic Regulation Act 1967

The Trunk Road (Ringwood, Hampshire) (Prohibition of Waiting) Order 1970

The Secretary of State for the Environment has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit the waiting of vehicles in that length of the Folkestone — Brighton — Southampton — Dorchester — Heart Road (A 21) Insert in part to South Honiton Trunk Road (A.31), known in part as Southampton Road and in part as the Ringwood By-pass, in the Parish of Ringwood in the County of Hamp-shire, which extends from the junction of South-ampton Road with Eastfield Lane to a point 50 yards west of the junction of the Ringwood By-pass with Southampton Road (B.3077).

Exceptions are provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
