Notice is hereby given that the Urban District Council of Hoylake propose to make an Order under section 1 (1), (2) and (3) and section 2 (4) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to:

Prohibit the waiting by vehicles at any time in:

Northerly side—from the kerb line on the westerly side of Market Street in a westerly direction for a distance of 551 feet.

Southerly side—from the kerb line on the westerly side of Market Street in a westerly direction for a distance of 56 feet.

- Market Street. South-easterly side—from its junction with Lake Place in a south-westerly direction for a distance of 91 feet.
- 3. Shaw Street. From the kerb line on the westerly side of Market Street in a westerly direction for a distance of 58 feet.
- 4. Trinity Road. From the kerb line on the westerly side of Market Street in a westerly direction for a distance of 66 feet.
- Wood Street. From the kerb line on the westerly side of Market Street in a westerly direction for a distance of 56 feet.

The Order will contain the usual exceptions permitting vehicles to wait to enable persons to board or alight; to enable goods to be loaded or unloaded; or alight; to enable goods to be loaded or unloaded; in connection with any funeral, building operation or demolition; to enable works to be carried out in any of the roads or lengths of road concerned; to enable a vehicle to be used in pursuance of statutory powers or duties; or to enable a vehicle to take in petrol, oil, water or air from a garage.

Urban District of Haylake (School Lane, Haylake) (Revocation and Prohibition of Driving) Order 1971

Notice is hereby given that the Urban District Council of Hoylake propose to make an Order under section 1 (1), (2) and (3) and section 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which will be to:

- A. Revoke The County Council of the County Palatine of Chester Roads (Traffic Regulation) Order 1937 (No. 1) which provided for one-way traffic in School Lane, Hoylake.
- B. Amend The Urban District of Hoylake (Various Streets, Hoylake) (Traffic Regulation) No. 2 Order 1968 by the deletion of the prohibition of waiting restrictions in respect of School Lane, Hoylake.
- C. Prohibit vehicles from being driven in School Lane, Hoylake:
 - (1) from its junction with Market Street for a distance of 37 yards in a north-westerly direc-
 - (2) from its junction with Hazel Road for a distance of 53 yards in a south-easterly direction;
 - (3) from a point 37 yards from its junction with Market Street for a distance of 24 yards in a north-westerly direction.

The Order will contain exceptions permitting vehicles to proceed in the lengths of road referred to in C(1) and (2) for the purposes of access to any premises situated on or adjacent to the said road for so long as may be necessary to enable persons to board or alight; to enable goods to be loaded or unloaded; in connection with any funeral, building operation or demolition; to enable works to be carried out in the road concerned; to enable a vehicle to be used in pursuance of statutory powers or duties; and for disabled drivers.

A copy of the proposed Order and map showing the road to which the Order relates may be inspected at the Town Hall, Hoylake, between 9 a.m. and 5 p.m. Mondays to Fridays.
