The Secretary of State for the Environment proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the waiting of vehicles on the side and length of the London—Holyhead Trunk Road (A.45), known as Fletchamstead Highway and Kenpas Highway, in the City and County of Coventry specified in Schedule 1 to this notice; and in four lay-bys situated on the western side of the above-mentioned trunk road specified in Schedule II to this notice. Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic

An additional exemption will also be included to allow a vehicle to wait for longer than the specified time on the sides of road where waiting is limited to 40 minutes in any 2 hours if the vehicle is an invalid carriages, a vehicle issued to a disabled person by the Department of Health and Social Security, a vehicle which bears at the front and rear yellow badges issued by a local authority in pursuance of a scheme under section 29 of the National Assistance Act 1948 or a vehicle left by a driver who on account of his severe physical disability has been given notice in writing by the Ross-on-Wye Urban District Council that he is exempt from the restriction.

The Trunk Road (High Street and Bury Road, Newmarket) (Prohibition and Restriction of Waiting) Order.

The Secretary of State for the Environment proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to amend existing restrictions on the waiting of vehicles on lengths of the London—Norwich Trunk Road (A.11), known as High Street in the Urban District of Newmarket, and to introduce new restrictions so that:

(a) no vehicle may wait on the sides of High Street specified in Schedule 1 to this notice;
(b) no vehicle may wait for more than 20 minutes

in any one hour on the side of High Street specified in Schedule 2 to this notice;

(c) no vehicle may wait for more than one hour in any four hours between the hours of 8 a.m. and 6 p.m. on the sides of High Street specified in Schedule 3 to this notice.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein and the removal of any obstruction to traffic, the maintenance of the road or the services therein, and disabled drivers' vehicles will be exempted from the time limits mentioned at (b) and (c) above.
