The County Borough of Hartlepool (Traffic Regulation (No. 5) Order 1969) Variation Order 1970.

Notice is hereby given that the Council of the County Borough of Hartlepool in exercise of their powers under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and of all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with section 84 C(i) of the said Act of 1967, have made the above Order the effect of which is to exclude from the provisions of the County Borough of Hartlepool Traffic Regulation (No. 5) Order 1969 part of the east side of Swainson Street from a point 45 feet north of its junction with Victoria Road in a northerly direction for a distance of 50 feet.

The Order came into effect on 11th December 1970.

HEREFORD CITY COUNCIL

The City of Hereford (Bewell Street Stub Road) (Prohibition of Waiting) Order 1971

Notice is hereby given that the Hereford City Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the waiting of vehicles at all times in the following length of road:

Bewell Street Stub Road from its junction with *Bewell Street* to its junction with *Eign Gate*, at total distance of 20 yards.

LANCASHIRE COUNTY COUNCIL

The Lancashire County Council (Hawksgarth Estate, Hawkshead, North Lonsdale Rural District) (Prohibition of Driving) Order 1971

Notice is hereby given that the Lancashire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the driving of motor vehicles, except for access, in *Hawksgarth Estate* at *Hawkshead* in the *Rural District of North Lonsdale*.

The Order will contain exemptions to allow the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the length of road; for the purposes of agriculture or timber felling; and in connection with any building operation or demolition and the maintenance of essential services.

A copy of the draft Order, plan and Statement of Reasons for proposing to make the Order may be inspected at the offices of the North Lonsdale Rural District Council, Council Offices, Todbusk, Springfield Road, Ulverston, and at County Hall, Preston, during normal office hours until the 18th January 1971.

LINCOLN CITY COUNCIL

City of Lincoln (Bailgate Area) (General Traffic Regulation) Order, 1971

Notice is hereby given that the Lincoln County Borough Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be to:

1. revoke the Traffic Regulation Orders set out in the first Schedule hereto.
2. prohibit vehicles from proceeding in the roads listed in Schedule 2 other than in the direction specified.
3. prohibit waiting in any of the lengths of road specified in the third Schedule between the hours of 8 a.m. and 6 p.m.
4. limit waiting to 30 minutes in any 1 hour during the hours of 8 a.m. and 6 p.m. in the lengths of road specified in the fourth Schedule.
5. prohibit driving in the lengths of road specified in the fifth Schedule.

With regard to paragraphs 2, 3 and 4 above, exceptions will be made in the Order:

- (a) for picking up or setting down passengers.
- (b) for the maintenance of the road and the supply of essential services.
- (c) for the loading or unloading of goods.
- (d) to enable a vehicle to take in petrol etc.

With regard to paragraph 5 above, exceptions will be made in the Order:

- (a) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to any of the lengths of road specified.
- (b) for the maintenance of the roads and the supply of essential services.

A booklet explaining the proposals may be obtained free of charge from the undersigned.
