Shoreham-by-Sea: River Adur Bridge

Notice is hereby given that the County Council of the Administrative County of West Sussex have submitted to the Secretary of State for the Environment for confirmation, a Scheme authorising the construction of a road bridge across the River Adur in a position approximately 250 metres downstream of the Norfolk Bridge at Shoreham-by-Sea to carry a new road to be constructed by the County Council.
