

Laleham Park Nurseries, turns south from their south-west corner to enclose the site of a former icehouse, and then runs west to the Urban District boundary at the mid-stream of the River Thames. The line then turns north to follow the mid-stream of the river until opposite the northern curtilage of Rivebank, where it turns east to cross Staines Road and to pass behind the properties fronting on to The Broadway and Ashford Road as far as and including Nos. 27 and 29 Ashford Road. The line then turns south-east across Ashford Road to enclose the group of trees opposite these two properties and to complete the boundary on the eastern side of Ashford Road.
