And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of Charles Horace Yates and the exhibit thereto

And the petitioners by their counsel undertaking within one month of the restoration of the name of the above-named company to the register of companies (1) to forward to the Registrar of Companies as required by sections 124 and 126 of the above-mentioned Act a copy of the annual return of the said company for each of the years 1965 to 1969 (inclusive) and (2) to send to the Registrar of Companies as required by section 200 of the said Act a notification of any changes among the Directors of the said company or in its secretary or in their particulars
