Notice is hereby given that:

1. The Newcastle upon Tyne County Borough Council propose to make an Order under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

2. When this Order comes into effect it will (a) prohibit all vehicles from entering King Street at its junction with the Quayside in the City and County of Newcastle upon Tyne, and (b) remove the one-way restriction at present in force in King Street, Lombard Street and Queen Street.

3. CITY AND COUNTY OF
NEWCASTLE UPON TYNE*Scotswood Road Bus Lane (Prohibition of Entry and One-Way) Order 1971*

Notice is hereby given that:

1. The Newcastle upon Tyne County Borough Council propose to make an Order under Section 1(1), (2) and (3)

of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

2. When this Order comes into effect it will make it unlawful for any person (save as provided therein):

(a) to cause or permit any vehicle to enter those lengths of the carriageway situated approximately 5 yards (5 metres) north of Scotswood Road and having a width throughout of approximately 7 yards (6 metres) and extending from its junction with George Street to its junction with Elswick East Terrace and from its junction with Elswick East Terrace to its junction with Scotswood Road and hereinafter referred to as the Scotswood Road Bus Lane; and

(b) to cause or permit any vehicle to proceed in an easterly direction in those lengths of the carriageway of the said Scotswood Road Bus Lane extending from its junction with George Street to its junction with Elswick East Terrace and from its junction with Elswick East Terrace to its junction with Scotswood Road.
