The Oxfordshire County Council (Footpath No. 3 Tiddington) Public Path Diversion Order, 1971

Notice is hereby given that on the 30th March 1971 the Oxfordshire County Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert approximately 40 yards of the public right of way running from its junction with the road (which runs in a southerly direction from the junction with the A.418 leading to Manor Farm and Tiddington House) to a line running from the junction of the existing footpath with the said road in a northerly direction for approximately 43 yards alongside the highway boundary and thence in a westerly direction between the proposed development for a distance of approximately 40 yards and thence in a southerly direction to the rear of the proposed development to rejoin the existing footpath.
