#### *Town and Country Planning Acts 1962 and 1968*

The Secretary of State hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 to authorise the stopping up of a length of un-named road at Cae-Glogwyn, Cymau, in the Rural District of Hawarden in the County of Flintshire, to enable development consisting of sand and gravel quarrying to be carried out in accordance with planning permission granted to the Flintshire Sand and Gravel Company Limited on behalf of Flintshire County Council.

The proposed Order will require the provision of a new highway which shall be a footpath and which shall be maintainable at the public expense, for which the highway authority is to be Flintshire County Council.
