Save as provided in Article 6 of the Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays in the roads or in any of the lengths of roads specified in Schedule 2 to the Order.

- 4. Save as provided in Article 6 of the Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8 a.m. and 7 p.m. all the week in the roads or in any of the lengths of roads specified in Schedule 3 to the Order.
- 5. Save as provided in Article 6 of the Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait (1) between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays on that part of Middle Gate (a) from its junction with Boar Lane for a distance of 23 yards south westwards, (b) from its junction with Kirk Gate for a distance of 25 yards south westwards on the north west side and 22 yards south westwards on the south east side. (2) On the remainder of Middle Gate on the (a) south east side for more than 40 minutes in one hour between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays on those days of the month which bear odd number (b) north west side for more than 40 minutes in one hour between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays on those days of the month which bear even number. month which bear even number.

- (c) to enable such vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the roads or lengths of roads so referred to or the laying, erection, alteration or repair in or near the said roads or lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraphic Act, 1878.
- (d) to enable the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in pursuance of statutory power or duties;
- (e) to enable the vehicle, if it is in the service of or employed by the Post Office, to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
