The Import Duties (Temporary Exemptions) (No. 4) Order, 1971.

This Order provides that the goods listed in Schedule 1 shall be temporarily exempt from import duty, and those listed in Schedule 2 shall continue to be exempt from import duty, both until 1st January 1972, except for items for which an earlier day is specified.

The Order comes into operation on the 4th May 1971 and has been published as Statutory Instrument 1971 No. 667.
