Now, therefore, Her Majesty, in exercise of the powers conferred upon Her by section 3 of the Naval and Marine Pay and Pensions Act 1865, and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, the action and it is berely ordered as follows: to order, and it is hereby ordered, as follows:

- This Order may be cited as the Naval and Marine Pay and Pensions (Pensions) (Officers of Flag and General Rank) Order 1971.
- 2. The revised rates of retired pay and terminal grants in respect of service in the Royal Navy and Royal Marines, as specified in the Schedule annexed hereto, shall have effect from 1st January 1971.

SCHEDULE

Section I

Half Pay and Terminal Grants for Admirals of the Fleet

(a) An Admiral of the Fleet will be eligible during

(a) An Admiral of the Fleet will be eligible during periods subsequent to 31st December 1970 for which he does not receive full pay, for half pay at the rate of £7,000 a year.

(b) An Admiral of the Fleet granted half pay and whose last day of service on full pay is 31st December 1970 or later, may be awarded a terminal grant of £21,000 free of income tax, in addition to his half ray

An Admiral of the Fleet who has been awarded a terminal grant under this clause shall not be eligible
