The Trunk Road (Cowbridge By-pass) (Access Road) (One-Way Traffic) Order 1971

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, prohibiting the driving of any vehicle in a north-westerly direction in that length of the London—Fishguard Trunk Road (A 48) at Stubling Down in the County of Clamerar .48), at Stalling Down in the County of Glamorgan, (A (A.48), at Stalling Down in the County of Glamorgan, which forms an access road, and which extends from a point 185 yards south-east of the centre line of the bridge carrying the Llantwit Major—Newton Road (B.4270) over the Cowbridge By-Pass (A.48) in a north-westerly direction for a distance of 155 yards. Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers con-ferred by the Road Traffic Regulation Act 1967, as

amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 6th July 1971, apply to the High Court for the suspension or quashing of the Order.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Section 2 (3) of The Purchase Tax Act 1963, viz The Purchase Tax (No. 4) Order 1971:

This Order reduces to 11¹/₄ per cent., 18 per cent., 30 per cent. and 45 per cent. the rates of purchase tax on the classes of goods heretofore taxable res-pectively at 13¹/₄ per cent., 22 per cent., 36¹/₈ per cent. and 55 per cent.

This Order comes into operation on the 20th July 1971, and has been published as Statutory Instruments 1971 No. 1145.
