Public Path Diversion Order, 1971*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 17th July 1971, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Bedford Rural District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way (part of Awarded Footpath No. 1) running from River Lane to the Tempsford parish boundary, being that part which commences at the southern boundary of Field Ordnance No. 48 running generally in a southerly direction across the River Ouse by means of a footbridge, an island and a second footbridge into Field Ordnance No. 45 over a third footbridge then easterly to a fourth footbridge over a stream for a distance of 130 yards, to a line running from the eastern point of Field Ordnance No. 48 generally in a south-westerly, southerly and north-easterly direction to a footbridge over a stream for a distance of 200 yards.

Public Path Diversion Order, 1971*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 17th July 1971, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Bedford Rural District Council as an unopposed order.

The effect of the Order, if confirmed without modification, will be to divert:

(1) The public right of way (part of Footpath No. 14) leading from Silver Street, Stevington to Bromham being that part running from the northern corner of Field Ordnance No. 91 adjacent to No. 53, Silver Street in a southerly direction to the southern corner of such field for a distance of 173 yards to a line along the north-easterly, southerly and south-easterly boundaries of Field Ordnance No. 91 for a distance of 243 yards.

(2) The public right of way (part of Footpath No. 9) leading from Silver Street to Duck End being that part running from the northern corner of Field No. 91 adjacent to No. 53, Silver Street in a south-westerly direction to the north-east boundary of "The Elms", No. 57, Silver Street for a distance of 45 yards to a line running along the south-easterly and north-easterly boundaries of such property for a distance of 35 yards.
