

And upon hearing counsel for the petitioners and for the Registrar of Companies (the respondent).

And upon reading the said petition (as amended) the affidavit of Oliver Charles Richards filed the 15th July 1971 the Affidavit of Sheila Mabel Devine filed the 16th July 1971 and the exhibits in the said Affidavits respectively referred to.

And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of Oliver Charles Richards and the exhibit thereto.

And the petitioners by their counsel undertaking within one month of the restoration of the name of the above-named company to the register of companies (1) to forward to the Registrar of Companies as required by Sections 124 and 126 of the above-mentioned Act a copy of the annual return of the said company for each of the years 1967 to 1970 (inclusive) together with the documents annexed thereto as required by Section 127 of the said Act and (2) to send to the Registrar of Companies as required by Section 200 of the said Act a notification of any changes among the directors of the said company or in its secretary or in their particulars.

The Court ordered that the name of the above named Essex Sound Services Limited be restored to the register of companies.

And it was ordered that an office copy of this Order be delivered to the Registrar of Companies And pursuant to the above mentioned Act the said Essex Sound Services Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off.

And it was ordered that the Registrar of Companies do advertise this Order in his official name in the "London Gazette."

And it was ordered that the petitioners the said Essex Sound Services Limited and Sheila Mabel Devine do pay to the Registrar of Companies his costs of the said petition.
